Sealed bids/offers along with earnest money of Rs.50,000/- (Rupees Fifty Thousand Only) in case of Motor Car and Rs. 3,000/- (Rupees Three Thousand Only) each in case of Motor Cycles in the shape of Pay Order/ Demand Draft in favor of State Bank of Pakistan Banking Services Corporation Faisalabad shall be submitted till 11.30 AM **11-Feb-2022** at Chief Manager’s Section, SBP-BSC, Faisalabad.
4. Sealed bids will be opened on the same day i.e. **11-Feb-2022** at **12.00 PM** in presence of disposal Committee, Chief Manager and participating bidders.
5. The successful bidder will have to provide/submit **25%** of the total bid/offer price in the form of Pay Order/ Demand Draft on the spot/same day in favor of State Bank of Pakistan otherwise their bid will be considered as cancelled and the earnest money will be forfeited.
