- 1. The items are lying in premises of SBP Building Karachi Office on an "As is where is basis". Interested firm/company may visit the disposal items during office hours.
- 2. The firm offered highest bid will be declared as "SUCCESSFUL", and have to deposit 100% of thetotal offer price in form of pay orders/Bank draft within Seven (07) working days after the receiving of "Work Order", failing which, the above mentioned security amount will be forfeited and the bankreserves the rights to award the work to the Next Higher Bidder.
- **3.** Gate Money amounting to Rs. 25,000/- (Rupees Twenty Five Thousand Only) for package 01 only in the form of Pay order/demand Draft shall have to be deposited by the prospective firm/company for participation. Otherwise, Cheque or cash will not be acceptable. The aforementioned gate money will be returned to the unsuccessful firm/company through written request and authority letter on company letterheadafter lifting of disposal by the successful bidder.
- **4.** Lifting to be undertaken by successful firm/company after full payment and the firm will remove and lift the items at their own safety, risk, cost and labour from SBP premises within 07 working days.
