1. This Invitation to Bids follows the Procurement Advertisement (PA) No. ENGG./076353 /IPBC/ 2022-23 for the procurement of “SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF IP BASED SECURITY CAMERAS AT SBP BANKING SERVICES CORPORATION, MUZAFFARABAD OFFICE”.
2. The SBP Banking Services Corporation has reserved the funds for the procurement planned during the financial year 2022-23. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
3. SBP Banking Services Corporation now invites sealed bids from eligible Suppliers to acquire IP Based Cameras that meet the following eligibility criteria:
 - a. Bidder must be an Original Equipment Manufacturer (OEM) or a direct authorized agent/dealer of the OEM of the offered camera models in Pakistan;
 - b. The offered product(s) must have been installed at minimum 03 verifiable organizations in Pakistan during the last 5 (five) years; (at total cost of 1M or above for each project)
 - c. Bidder must have Annual Sales / Gross Turnover of at least Rs.3 million in any of the last five (05) financial years;
 - d. Bidder must be registered with Income Tax and Sales Tax Department and must appear on the Active Tax Payers List of FBR/AJK Council.
 - e. Bidder must not be blacklisted or in breach of performance with SBP or any Organization(s).
 - f. Bidder must have verifiable presence in Muzaffarabad/Islamabad/Rawalpindi;
 - g. Bidder must have technical strength of at least 1 OEM Certified and Trained Engineer
4. The bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
5. All bids must be accompanied by a Bid Security in an acceptable form amounting to **PKR 70,000/-**.

The original bid along with one (01) copy, properly filled in, and enclosed in sealed envelope(s), must be delivered at the PA to Chief Manager at 1st Floor, SBP Banking Services Corporation, Muzaffarabad on or before **Tuesday, February 07, 2023. 03:00 PM**. The technical bids will be opened same day at **03:30 PM** in the presence of bidders' representatives who choose to attend the opening at the **Chief Manager's Chamber located at 1st Floor, SBP Banking Services Corporation, Muzaffarabad**.
8. In case of public holiday, the bids will be opened at 03:30 PM on the next working day.
