- 1. This Invitation to Bids follows the Procurement Advertisement (PA) No. GSD (PROC-III)/07695 / Digital Walkie-Talkie / 2022-23 for the procurement of Supply, Installation, Testing and Commissioning of Digital Walkie-Talkie Hand Sets and Allied Ancillaries for SBP BSC Field Offices.
- 2. The SBP Banking Services Corporation has reserved the funds for the procurement planned during the financial year 2022-23. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
- **3.** SBP Banking Services Corporation now invites sealed bids from eligible Suppliers to acquire Digital Walkie-Talkie Hand Sets with Allied Ancillaries that meet the following eligibility criteria:
 - a. Bidder should be an Original Equipment Manufacturer (OEM) or OEM's authorized agent of offered walkie-talkie sets in Pakistan;
 - b. Bidders must have installed similar products at minimum 3 verifiable organizations in Pakistan during last 3 years;
 - c. Bidder must have Annual Sales volume/Gross Turnover of at least Rs. 10 million in any of the last 03 (three) years;
 - d. Bidder should have at least three (03) certified technicians/resources to carry out the repair and maintenance of supplied equipment(s);
 - e. Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;
 - f. Bidder must not have been blacklisted or be in breach of performance with SBP or any Organization(s).
- **4.** The bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- 5. All bids must be accompanied by a Bid Security in an acceptable form amounting to PKR 222,800/-.

- 7.
