Form of Contract Agreement Agreement for lifting of shredded waste of currency notes from <u>State Bank of Pakistan, SBP-BSC (Bank), Faisalabad</u>

This agreement is made onbetween State Bank of Pakistan, SBP-BSC(Bank) Faisalabad having its Head Office at Karachi (hereinafter called the Bank) on onepart and M/s(hereinafter called the Contractor) on the other part.

- 1. The contract will be effective for a period of one year starting from
- 2. The Contractor will pay to the bank in cash per Kg upon lifting of Shredded Waste Bags/Briquettes against proper receipt.
- 3. The sum of Rs. 300,000/- (Rupees One Hundred Thousand only) will be deposited by the Contractor as Security Deposit & will be refundable upon termination of the contract by either party.
- 4. The Security Deposit amount will be forfeited by the bank if the contractor fails to meet any of his obligations or in case of providing unsatisfactory services as determined by the bank.
- 5. Only those bidders can participate in the bidding process whose names are appearing in the active tax payer list of FBR.
- 6. Successful bidder will have to submit Advance Tax under section 236-A over and above the quoted rate and submit tax amount before removing the items from the premises.
- 7. No Price Adjustment shall be made for any variation in the market prices, taxes/ duties or change in wages or the Law.
- 8. The contractor will ensure sufficient supply of empty bags (at least 2000) of standard size in advance.
- 9. A penalty of Rs. 200/- per day shall be imposed if the empty bags are not provided in sufficient quantity to accommodate the shredding waste produced on daily basis.
- 10. The Bank reserves the right to recover any amount from the payable amounts to the Successful bidder against any losses or damages incurred to the property, data, or persons of the Employer due to the Successful bidder or his worker's negligence.
- 11. Contractor shall deposit bid security amounting to Rs. 20,000/- in shape of CDR along with the bid. any bid submitted without bid security will be rejected at time of opening.
- 12. It would be binding for the contractor to lift the desired quantity of shredded material bags/briquettes within the specified time as and when so advised continuously by the authorized Bank official (over phone/written or by any other

means of communication). Failure to do so shall result in a penalty of Rs. 500/- day for each day, if the lifting is delayed.

- 13. The contractor would be responsible to arrange vehicle(s) and suitable number of workers for lifting of shredded waste at his own cost, he will inform the bank about the particulars of the vehicle(s) and workers deputed for the job before lifting the shredded waste.
- 14. The contractor will be responsible for weighing, loading/unloading and subsequent disposal of the shredded waste bags/briquettes. All the expenses incurred in such arrangements shall be borne by the Contractor.
- 15. The shredded waste will be lifted after getting permission from the Currency Officer or any other authorized officer and would be loaded in the vehicle(s) in the supervision of security staff of the bank.
- 16. Shredded waste will be taken out from the Bank's premises upon issuance of "Gate Pass" by the bank authorities.
- 17. The contractor shall not use this shredded material other than as energy source/burning material in boilers only. Any other use of this material will be treated as violation of agreement and the bank shall reserve the right to terminate the contract immediately.
- 18. If any dispute arises between the parties (Successful bidder & the Bank), the matter shall be referred to the Director General Services Department (GSD) who will examine the matter in detail and give the decision which will be final & binding upon the parties
- 19. The contractor shall provide a Guarantee/Surety Bond for the contract period authorizing bank to deduct for any default of the contract as may be determined by Bank.
- 20. The Bank may terminate the agreement with the Contractor at any time without indicating any reason or informing the Contractor in advance.
- 21. The Bank may execute/sign such agreement with other parties also as and when deemed fit.
- 22. In case the contractor is inclined to terminate the contract, he will inform the bank at least 30 days in advance.
- 23. The agreement will be valid from to whereas upon satisfactory services by the Contractor, same may be extended / revised.
