1. This Invitation to Bids follows the Procurement Advertisement (PA) No. GSU (PROC)/ 32758 / CCTV / 2022-23 for the procurement of “Supply, Installation, Testing and Commissioning of IP Based CCTV System at SBP Banking Services Corporation, Quetta”.
2. The SBP Banking Services Corporation has reserved the funds for the procurement planned during the financial year 2022-23. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
3. SBP Banking Services Corporation now invites sealed bids from eligible Suppliers to acquire CCTV System that meet the following eligibility criteria:
  - a. Bidder must be Original Equipment Manufacturer (OEM) or OEM’s Authorized Agent of the offered CCTV Cameras in Pakistan;
  - b. Bidder must have experience of supplying/installing 50 CCTV Cameras in at least 03 (three) verifiable organizations during last 05 (five) years;
  - c. Bidder must have Annual Sales volume/Gross Turnover of at least Rs. 05 million in any of the last 03 (three) years;
  - d. Bidder should have at least three (03) certified technicians/resources to carry out the repair and maintenance of supplied equipment(s);
  - e. Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;
  - f. Bidder must not have been blacklisted or be in breach of performance with SBP or any Organization(s).
4. The bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
5. All bids must be accompanied by a Bid Security in an acceptable form amounting to PKR 17,000/-.

7. The original bid along with one (01) copy, properly filled in, and enclosed in sealed envelope(s), must be delivered at the office of the undersigned on or before **Friday, July 07, 2023. 11:00 AM**. The bids (technical part of the bids) will be opened same day at **11:30 AM** in public and in the presence of bidders’ representatives who choose to attend the opening at the **Meeting Room, 1<sup>ST</sup> Floor Main Building, State Bank of Pakistan Banking Services Corporation, Gulistan Road, Quetta–Pakistan**.

## Section II. Instructions to Bidders (ITBs)

<b><u>A. Introduction</u></b>	
<b>1. Scope of Application</b>	1.1 The Procuring Agency (PA), as indicated in the <b>Bid Data Sheet (BDS)</b> invites Bids for the “Supply, Installation, Testing and Commissioning of IP Based CCTV System at SBP Banking Services Corporation, Quetta” as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to supply and install the equipment within the specified period and timeline(s) as stated in the BDS.
<b>2. Sources of Funds</b>	2.1 Source of funds is referred in Clause-2 of Invitation to Bids.
<b>3. Eligible Bidders</b>	<p>3.1 A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or of any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.</p> <p>3.2 The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.</p> <p>3.3 Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.</p> <p>3.4 Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.</p> <p>3.5 The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.</p>



	<p>3.6 Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.</p> <p>3.7 A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:</p> <ul style="list-style-type: none"><li>a. are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of goods and related services to be procured under this Invitation for Bids.</li><li>b. have controlling shareholders in common; or</li><li>c. receive or have received any direct or indirect subsidy from any of them; or</li><li>d. have the same legal representative for purposes of this Bid; or</li><li>e. have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; or</li><li>f. Submit more than one Bid in this Bidding process.</li></ul> <p>3.8 A Bidder may be ineligible if –</p> <ul style="list-style-type: none"><li>a. he is declared bankrupt or, in the case of company or firm, insolvent;</li><li>b. payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property;</li><li>c. legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;</li></ul>

	<p>d. the Bidder is convicted, by a final judgment, of any offence involving professional conduct;</p> <p>e. the Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration.</p> <p>f. The firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them.</p> <p>3.9 Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.</p> <p>3.10 Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.</p> <p>3.11 Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged.</p>
<p><b>4. Eligible Goods and Related Services</b></p>	<p>4.1 All the goods and related services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to such goods and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as “Eligible Countries”.</p> <p>4.2 For purposes of this Clause, “origin” means the place where the goods are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied.</p> <p>4.3 The nationality of the supplier that supplies and install the goods shall not determine the origin of the goods.</p> <p>4.4 To establish the eligibility of the Goods and the related services, Bidders shall fill the country of origin declarations included in the Form of Bid.</p> <p>4.5 If so required in the <b>BDS</b>, the Bidder shall demonstrate that it has been duly authorized by the manufacturer of the goods to deliver</p>



	in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the goods indicated in its Bid.
<b>5. One Bid per Bidder</b>	<p>5.1 A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.</p> <p>5.2 No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.</p> <p>5.3 A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.</p>
<b>6. Cost of Bidding</b>	6.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
<b><u>B. Bidding Documents</u></b>	
<b>7. Contents of Bidding Documents</b>	<p>7.1 The goods required, bidding procedures, and terms and conditions of the contract are prescribed in the Bidding Documents. In addition to the Invitation to Bids, the Bidding Documents which should be read in conjunction with any addenda issued in accordance with ITB 9.2 include:</p> <p style="padding-left: 40px;"><b>Section I</b> -Invitation to Bids  <b>Section II</b> Instructions to Bidders (ITBs)  <b>Section III</b> Bid Data Sheet (BDS)  <b>Section IV</b> Eligible Countries  <b>Section V</b> Schedule of Requirements and Technical Specifications  <b>Section VI</b> Standard Forms  <b>Section VII</b> General Conditions of Contract (GCC)  <b>Section VIII</b> Special Conditions of Contract (SCC)  <b>Section IX</b> Contract Forms</p> <p>7.2 The number of copies to be completed and returned with the Bid is specified in the <b>BDS</b>.</p> <p>7.3 The Procuring Agency is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Procuring Agency or the signed pdf version from downloaded from the website of the Procuring Agency. However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.</p> <p>7.4 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all</p>

	<p>the information required in the Bidding Documents will be at the Bidder’s risk and may result in the rejection of his Bid.</p>
<p><b>8. Clarification of Bidding Documents</b></p>	<p>8.1 A prospective Bidder requiring any clarification of the Bidding Documents may notify the Procuring Agency in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the <b>BDS</b>.</p> <p>8.2 The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in <b>ITB 23.1</b>. However, this clause shall not apply in case of alternate methods of Procurement.</p> <p>8.3 Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source.</p> <p>In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.</p> <p>8.4 Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under <b>ITB 9</b>.</p> <p>8.5 If indicated in the <b>BDS</b>, the Bidder’s designated representative is invited at the Bidder’s cost to attend a pre-Bid meeting at the place, date and time mentioned in the <b>BDS</b>. During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.</p> <p>8.6 Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-Bid meeting shall be made by the Procuring Agency exclusively through the use of an Addendum pursuant to <b>ITB 9</b>. Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.</p>
<p><b>9. Amendment of Bidding Documents</b></p>	<p>9.1 Before the deadline for submission of Bids, the Procuring Agency for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder or pre-bid meeting may modify the Bidding Documents by issuing addenda.</p>



	<p>9.2 Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to <b>ITB 7.1</b> and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the Procuring Agency. The Procuring Agency shall promptly publish the Addendum at the Procuring Agency's web page identified in the BDS: Provided that the bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.</p> <p>9.3 To give prospective Bidders reasonable time in which to take an addendum/corrigendum into account in preparing their Bids, the Procuring Agency may, at its discretion, extend the deadline for the submission of Bids: Provided that the Procuring Agency shall extend the deadline for submission of Bid, if such an addendum is issued within last three (03) days of the Bid submission deadline.</p>
<p><b><u>C. Preparation of Bids</u></b></p>	
<p><b>10. Language of Bid</b></p>	<p>10.1 The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Procuring Agency shall be written in the English language unless otherwise specified in the <b>BDS</b>. Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the <b>BDS</b>, in which case, for purposes of interpretation of the Bidder, the translation shall govern.</p>
<p><b>11. Documents and Sample(s) Constituting the Bid</b></p>	<p>11.1 The Bid prepared by the Bidder shall constitute the following components: -</p> <ol style="list-style-type: none"> <li>a) Form of Bid and Bid Prices completed in accordance with <b>ITB 14 and 15</b>;</li> <li>b) Details of the Sample(s) where applicable and requested in the <b>BDS</b>.</li> <li>c) Documentary evidence established in accordance with ITB 13 that the Bidder is eligible and/or qualified for the subject bidding process;</li> <li>d) Documentary evidence established in accordance with <b>ITB 13.3(a)</b> that the Bidder has been authorized by the manufacturer to deliver the goods into Pakistan, where required and where the supplier is not the manufacturer of those goods;</li> <li>e) Documentary evidence established in accordance with ITB 12 that the goods and related services to be supplied by the</li> </ol>

	<p>Bidder are eligible goods and services, and conform to the Bidding Documents;</p> <ul style="list-style-type: none"> <li>f) Bid security or Bid Securing Declaration furnished in accordance with <b>ITB 18</b>;</li> <li>g) Duly Notarized Power of Attorney authorizing the signatory of the Bidder to submit the bid; and</li> <li>h) Any other document required in the <b>BDS</b></li> </ul> <p>11.2 Where a sample(s) is required by a procuring agency, the sample shall be:</p> <ul style="list-style-type: none"> <li>(a) submitted as part of the bid, in the quantities, dimensions and other details requested in the <b>BDS</b>;</li> <li>(b) carriage paid;</li> <li>(c) received on, or before, the closing time and date for the submission of bids; and</li> <li>(d) evaluated to determine compliance with all characteristics listed in the <b>BDS</b>.</li> </ul> <p>11.3 The Procuring Agency shall retain the sample(s) of the successful Bidder. A Procuring Agency shall reject the Bid if the sample(s)-</p> <ul style="list-style-type: none"> <li>(a) do(es) not conform to all characteristics prescribed in the bidding documents; and</li> <li>(b) is / are not submitted within the specified time clearly mentioned in the Bid Data Sheet.</li> </ul> <p>11.4 Where it is not possible to avoid using a propriety article as a sample, a Bidder shall make it clear that the propriety article is displayed only as an example of the type or quality of the goods being Bided for, and that competition shall not thereby be limited to the extent of that article only.</p> <p>11.5 Samples made up from materials supplied by a Procuring Agency shall not be returned to a Bidder nor shall a Procuring Agency be liable for the cost of making them.</p> <p>11.6 All samples produced from materials belonging to an unsuccessful Bidder shall be kept by the Procuring Agency till thirty (30) days from the date of award of contract or exhaust of all the grievance forums (including those pending at Authority's Level or in some Court of Law).</p>
<p><b>12. Documents Establishing Eligibility of the Goods and Related Services and</b></p>	<p>12.1 Pursuant to ITB 11, the Bidder shall furnish, as part of its Bid, all those documents establishing the eligibility in conformity to the terms and conditions specified in the Bidding Documents for all goods and related services which the Bidder proposes to deliver.</p>



<p><b>Conformity to Bidding Documents</b></p>	<p>12.2 The documentary evidence of the eligibility of all goods and related services shall consist of a statement in the Price Schedule of the country of origin of the goods and related services offered which shall be confirmed by a certificate of origin issued at the time of shipment.</p> <p>12.3 The documentary evidence of conformity of the goods and related services to the Bidding Documents may be in the form of literature, drawings, and data, and shall consist of:</p> <ul style="list-style-type: none"> <li>a. a detailed description of the essential technical specifications and performance characteristics of the Goods;</li> <li>b. an item-by-item commentary on the Procuring Agency's Technical Specifications demonstrating substantial responsiveness of the Goods and Services to those specifications, or a statement of deviations and exceptions to the provisions of the Technical Specifications;</li> <li>c. any other procurement specific documentation requirement as stated in the BDS.</li> </ul> <p>12.4 The Bidder shall also furnish a list giving full particulars, including available sources and current prices of goods, spare parts, special tools, etc., necessary for the proper and continuing functioning of the Goods during the period <b>specified in the BDS</b> following commencement of the use of the goods by the Procuring Agency.</p> <p>12.5 For purposes of the commentary to be furnished pursuant to <b>ITB 12.3(c)</b> above, the Bidder shall note that standards for workmanship, material, and equipment, as well as references to brand names or catalogue numbers designated by the Procuring Agency in its Technical Specifications, are intended to be descriptive only and not restrictive. The Bidder may substitute alternative standards, brand names, and/or catalogue numbers in its Bid, provided that it demonstrates to the Procuring Agency's satisfaction that the substitutions ensure substantial equivalence to those designated in the Technical Specifications.</p> <p>12.6 The required documents and other accompanying documents must be in English. In case any other language than English is used the pertinent translation into English shall be attached to the original version.</p>
<p><b>13. Documents Establishing the Eligibility and Qualification of the Bidder</b></p>	<p>13.1 Pursuant to <b>ITB 11</b>, the Bidder shall furnish, as part of its Bid, all those documents establishing the Bidder's eligibility to participate in the bidding process and/or its qualification to perform the contract if its Bid is accepted.</p> <p>13.2 The documentary evidence of the Bidder's eligibility to Bid shall establish to the satisfaction of the <b>Procuring Agency</b> that the Bidder, at the time of submission of its bid, is from an eligible country as defined in Section-4 titled as "Eligible Countries".</p>

The estimated time of arrival of the goods at the Project Site will be calculated for each Bid after allowing for reasonable international and inland transportation time. Treating the Bid resulting in such time of arrival as the base, a delivery “adjustment” will be calculated for other Bids by applying a percentage, specified in the **BDS**, of the EXW or as per applicable INCOTERM price for each week of delay beyond the base, and this will be added to the Bid price for evaluation. *c. Deviation in Payment Schedule*

*f. Operating and maintenance costs*

- h) **“Defective Goods”** are those goods which are below standards, requirements or specifications stated by the Contract.
- i) **“Delivery”** means the transfer of the goods from the supplier equipment, machinery, and /or other materials which the Supplier is required to supply to the Procuring Agency under Contract.
- j) **“Effective Contract date”** is the date shown in the Certificate of Contract Commencement issued by the Procuring Agency upon fulfillment of the conditions precedent stipulated in **GCC Clause 3**.
- k) **“Procuring Agency”** means the person named as Procuring Agency in the **SCC** and the legal successors in title to this person, procuring the Goods and related service, as named in **SCC**.
- l) **“Related Services”** means those services ancillary to the delivery of the Goods, such as transportation and insurance, and any other incidental services, such as installation, commissioning, provision of technical assistance, training, initial maintenance and other such obligations of the Supplier covered under the Contract.
- m) **“GCC”** means the General Conditions of Contract contained in this section.
- n) **“Intended Delivery Date”** is the date on which it is intended

- t) **“End User”** means the organization(s) where the goods will be used, as named in the **SCC**.
- u) **“Origin”** means the place where the Goods were mined, grown, or produced or from which the Services are supplied. Goods are produced when, through manufacturing, processing, or substantial and major assembly of components, a commercially recognized new produce results that is substantially different in basic characteristics or in purpose or utility from its components.
- v) **“Force Majeure”** means an unforeseeable event which is beyond reasonable control of either Party and which makes a Party’s performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances.  
 For the purposes of this Contract, **“Force Majeure”** means an event which is beyond the reasonable control of a Party, is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of a Party, and which makes a Party’s performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances. and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood, epidemics, or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by Government agencies.

## **Appendix 9 –Service Level Maintenance Agreement**

### **Service Scope**

The Supplier shall, with due care, diligence and attention, provide the supply, installation, configuration, warranty and technical support services to the full satisfaction of the Purchaser, and assign properly qualified and competent personnel having related product maintenance experience, state of the art methods and economic principles, and exercise all reasonable means required to ensure quality services in accordance with this Contract and the terms contained in this Appendix.

The Purchaser will provide all necessary details to the Supplier to configure the equipment for required service.

The Supplier will make all reasonable endeavors to provide the above mentioned services within the "Response Time" stated below and to perform the Repair and Replacement Services on or off the Customer's premises.

Supplier will provide a detailed plan, availability of manpower, spares and standby equipment as well as service methodology to meet the Purchaser's requirements in a prompt and most efficient manner within two weeks of signing the Contract.

### **Response and Repair time:**

- a) The Supplier will provide the Purchaser the contact details of Help Desk and a Log Book shall be maintained by the engineer/technician of all work performed for the purchaser. Supplier will assign an Account Manager for the Bank, who would be endowed with enough financial and administrative authority to take decisions on time as and when required.
- b) The supplier shall ensure the presence of technically qualified engineer/technician during normal working hours of the bank on all working days.
- c) The engineer/technician shall be responsible to perform servicing/cleaning/maintenance of the equipment as specified by the OEM and on request of the purchaser to ensure their smooth operations.
- d) In case of failure of any part/component and repair at local workshop, the part/component shall be taken to the local service center of the Supplier, manufacturer or its authorized agent branch or head office. After repairing, it shall be returned to the Purchaser's premises within 72 hours. If the part/component is not returned within the stipulated timeframe, back-up equipment of equivalent specifications must be provided to the purchaser.
- e) In case the faulty item or unit is required to be sent outstation/overseas for repair or replacement services then Supplier will send the faulty part/component and deliver the replacement or repaired to the Purchaser site(s) at its own cost.

### **Warranty Period**

All equipment shall carry a warranty for a period of not less than Two (02) years from the date of Operational Acceptance. All equipment shall be free from defective material and workmanship and any shortfall/defect that may appear/be detected within 24 months from the date of Operational Acceptance. During the warranty period, the equipment shall be serviced as and when necessary and the defective items shall be replaced free of charge. The supplier's engineer/technician shall attend to scheduled/unscheduled maintenance free of charge during this period as also specified in the Service Level Agreement (SLA).

The supplier shall ensure the availability of spares and technically qualified engineers/technicians to carry out the necessary repairs to the equipment during their expected lifespan for a period not less than 5 years from the date of Operational Acceptance.

Supplier will depute technically qualified engineer/technician having related product maintenance experience, to ensure quality services during the entire contract period.

After delivery of equipment, the Supplier with due care and diligence, shall install and configure the equipment time to time according to business needs of the bank. Comprehensive warranty (with free parts and labor) and technical support services as per require SLA will be provided by the supplier up to the full satisfaction of the Purchaser.

### **Service Level Agreement (SLA)**

The scope of the Service Level Agreement (SLA) covers warranty and post-warranty period including all taxes, duties, levies and other transport, handling, insurance charges, etc. for the following:

- i. Routine servicing, trouble shooting, settings, adjustments, cleaning to ensure smooth and trouble free working of the system as and when required or as recommended by the OEM;
- ii. Expenses related to the deployment of technically qualified engineer/technician (during working hours on working days), during & post-warranty period shall be covered in the cost of SLA. The Bank will not be liable to make any extra payments other than those noted in the price schedule of bidding documents.
- iii. Repairs to the equipment and troubleshooting of software in the event of any breakdown shall be deemed to have been included in the SLA cost.
- iv. Technical support and provision of upgrades for system software, if required.
- v. In case of any hardware part/component failure, the reporting engineer will extensively check it at purchaser's specified location and will deliver it back to incident site after replacement, within specified resolution time (72 hours). If the part/component is not returned within the stipulated timeframe, a back-up part/component of equivalent specifications must be provided to the purchaser.
- vi. Undertake corrective actions and repairs to rectify such aberration i.e. hardware failure, software installations, operating system reinstallation.
- vii. Other than the routine maintenance, the supplier will perform preventive/mandatory maintenance by assuring presence and visit of technical expert on quarterly basis during the warranty period and pay at least one visit per quarter during SLA period after the supplied equipment and check its parameters and provide onsite service and support to keep the equipment in good working condition.
- viii. The "Routine Preventive Maintenance Visits" as well as the "Special Visits On-Call" shall be attended and carried out only on working days (Monday to Friday) and normal office working hours.
- ix. Cost of all spare parts shall be charged to the purchaser separately and shall be applicable after Completion of Warranty Period only.
- x. The scope of SLA also covers complete maintenance of supplied software(s) for the entire system.

**The selected bidder will be required to provide necessary CNIC of the Project Manager, Engineers, Technicians, labors and other logistic resources etc. working within the Purchaser's site(s) during the contract Period.**

**Operational Acceptance**

Operational Acceptance means that the supplies and services in the contract have been installed and run in operations after testing in accordance with the products' parameters mentioned in the technical specifications and features meeting the technical requirements of the product.

At least fifteen (15) days of successful operations of the installed system, in accordance with the purchaser required configuration, will confirm the Operational Acceptance of all the supplies under this contract. Also the supplier will ensure dedicated on-site support till operational acceptance.

Any component identified and confirmed through OEM/Distributor or Dealer or by Physical Inspection or performance to be non-genuine, copy or refurbished will be rejected for acceptance and it will be supplier's responsibility to replace that component or the entire lot failing which the purchaser may terminate the contract.

Any testing related cost shall be borne by the supplier.

***During the course of the project until the operational acceptance of the last installation is signed by the representative of the Bank, any cost associated with the repair or replacement of the supplies in this contract will remain covered in Warranty or SLA accordingly***
