- 1. This Invitation to Bids follows the Procurement Advertisement (PA) No. GSD (PROC-III)/ 84919 / Barcode Verification System / 2023-24 for the procurement of "Supply, Installation, Integration and Commissioning of Barcode Readable Verification System at SBP Banking Services Corporation".
- 2. The SBP Banking Services Corporation (SBP BSC) has reserved the funds for the procurement planned during the financial year 2023-24. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
- **3.** SBP BSC now invites sealed bids from eligible Suppliers to acquire *Barcode Readable Verification System* that meet the following eligibility criteria:
 - a. Bidder must be Original Equipment Manufacturer (OEM) or OEM's Authorized Agent of the offered Equipment in Pakistan;
 - b. Bidder must have experience of supplying similar supplies to at least 03 (three) verifiable organizations during last 05 (five) years;
 - c. Bidder must have Annual Sales volume/Gross Turnover of at least PKR. 10 (ten) million in any of the last 03 (three) years;
 - d. Bidder must have verifiable presence in Karachi;
 - e. Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;
 - f. Bidder must not have been blacklisted or be in breach of performance with SBP or any Organization(s).
- **4.** The Bidding shall be conducted in line with Rule 36(b) Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 (PPR-2004) and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- 5. All technical bids must be accompanied by a Bid Security in an acceptable form amounting to PKR 80,000/-

- 7.
