1. Scope of Application 1.1	The Procuring Agency (PA), as indicated in the Bid Data Sheet (BDS) invites

	will be expected to deliver the goods within the specified period and timeline(s)
2.1	as stated in the BDS.
2. Sources of Funds 2.1	Source of funds is referred in Clause-2 of Invitation to Bids.
3. Eligible Bidders 3.1	A Bidder may be natural person, company or firm or public or semi-public
	agency of Pakistan or of any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture,
	consortium, or association. In the case of a joint venture, consortium, or
	association, all members shall be jointly and severally liable for the execution of
	the Contract in accordance with the terms and conditions of the Contract. The
	joint venture, consortium, or association shall nominate a Lead Member as
	nominated in the BDS, who shall have the authority to conduct all business for
	and on behalf of any and all the members of the joint venture, consortium, or
	association during the Bidding process, and in case of award of contract, during
	the execution of contract.
3.2	The appointment of Lead Member in the joint venture, consortium, or
	association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.
3.3	Verifiable copy of the agreement that forms a joint venture, consortium or
	association shall be required to be submitted as part of the Bid.
3.4	Any bid submitted by the joint venture, consortium or association shall indicate
	the part of proposed contract to be performed by each party and each party shall
	be evaluated (or post qualified if required) with respect to its contribution only,
	and the responsibilities of each party shall not be substantially altered without
	prior written approval of the Procuring Agency and in line with any instructions
3.5	issued by the Authority.
3.3	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing
	by the respective national incorporating agency or statutory body established for
	that particular trade or business.
3.6	Foreign Bidders must be locally registered with the appropriate national
	incorporating body or the statutory body, before participating in the
	national/international competitive tendering with the exception of such
	procurements made by the foreign missions of Pakistan. For such purpose the
	bidder must have to initiate the registration process before the bid submission
	and the necessary evidence shall be submitted to the procuring agency along
	with their bid, however, the final award will be subject to the complete registration process.
3.7	A Bidder shall not have a conflict of interest. All Bidders found to have a conflict
]	of interest shall be disqualified. A Bidders may be considered to have a conflict
	of interest with one or more parties in this Bidding process, if they:
	a. are associated or have been associated in the past, directly or indirectly
	with a firm or any of its affiliates which have been engaged by the
	Procuring Agency to provide consulting services for the preparation of

	c. receive or have received any direct or indirect subsidy from any of them;

have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; or Submit more than one Bid in this Bidding process. 3.8 A Bidder may be ineligible if – he is declared bankrupt or, in the case of company or firm, insolvent; payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property; legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property; d. the Bidder is convicted, by a final judgment, of any offence involving professional conduct; the Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration. The firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them. 3.9 Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively. 3.10 Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request. 3.11 Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged. Eligible and 4.1 All the goods and related services to be supplied under the contract shall have Goods **Related Services** their origin in eligible source countries, and all expenditures made under the contract will be limited to such goods and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as "Eligible Countries". 4.2 For purposes of this Clause, "origin" means the place where the goods are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied. 4.3 The nationality of the supplier that supplies and install the goods shall not determine the origin of the goods. 4.4 To establish the eligibility of the Goods and the related services, Bidders shall fill the country of origin declarations included in the Form of Bid. 4.5 If so required in the BDS, the Bidder shall demonstrate that it has been duly authorized by the manufacturer of the goods to deliver in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the goods indicated in its Bid.

- 11.2 Where a sample(s) is required by a procuring agency, the sample shall be:
  - (a) submitted as part of the bid, in the quantities, dimensions and other details requested in the **BDS**;
  - (b) carriage paid;
  - (c) received on, or before, the closing time and date for the submission of bids; and
  - (d) evaluated to determine compliance with all characteristics listed in the **BDS**.
- 11.3 The Procuring Agency shall retain the sample(s) of the successful Bidder. A Procuring Agency shall reject the Bid if the sample(s)-
  - (a) do(es) not conform to all characteristics prescribed in the bidding documents; and
  - (b) is / are not submitted within the specified time clearly mentioned in the Bid Data Sheet.
- 11.4 Where it is not possible to avoid using a propriety article as a sample, a Bidder shall make it clear that the propriety article is displayed only as an example of the type or quality of the goods being Bided for, and that competition shall not thereby be limited to the extent of that article only.
- 11.5 Samples made up from materials supplied by a Procuring Agency shall not be returned to a Bidder nor shall a Procuring Agency be liable for the cost of making them.
- 11.6 All samples produced from materials belonging to an unsuccessful Bidder shall be kept by the Procuring Agency till thirty (30) days from the date of award of contract or exhaust of all the grievance forums (including those pending at Authority's Level or in some Court of Law).
- 12. Documents Establishing Eligibility of the Goods and Related Services and Conformity to Bidding Documents
- 12.1 Pursuant to ITB 11, the Bidder shall furnish, as part of its Bid, all those documents establishing the eligibility in conformity to the terms and conditions specified in the Bidding Documents for all goods and related services which the Bidder proposes to deliver.
- 12.2 The documentary evidence of the eligibility of all goods and related services shall consist of a statement in the Price Schedule of the country of origin of the goods and related services offered which shall be confirmed by a certificate of origin issued at the time of shipment.
- 12.3 The documentary evidence of conformity of the goods and related services to the Bidding Documents may be in the form of literature, drawings, and data, and shall consist of:
  - a. a detailed description of the essential technical specifications and performance characteristics of the Goods;
  - an item-by-item commentary on the Procuring Agency's Technical Specifications demonstrating substantial responsiveness of the Goods and Services to those specifications, or a statement of deviations and exceptions to the provisions of the Technical Specifications;
  - c. any other procurement specific documentation requirement as stated in the BDS.
- 12.4 The Bidder shall also furnish a list giving full particulars, including available sources and current prices of goods, spare parts, special tools, etc., necessary for the proper and continuing functioning of the Goods during the period **specified in the BDS** following commencement of the use of the goods by the Procuring Agency.
- 12.5 For purposes of the commentary to be furnished pursuant to **ITB 12.3(c)** above, the Bidder shall note that standards for workmanship, material, and equipment, as well as references to brand names or catalogue numbers designated by the Procuring Agency in its Technical Specifications, are intended to be descriptive only and not restrictive. ### a) For goods manufactured from within Pakistan (or within the country where procurement is being done in case of foreign missions abroad):

- i. The price of the goods quoted EXW (ex-works, ex-factory, exwarehouse, ex-showroom, or off-the-shelf, as applicable), including all customs duties and sales and other taxes already paid or payable:
  - A. on the components and raw material used in the manufacturing or assembly of goods quoted ex- works or ex-factory; OR
  - B. on the previously imported goods of foreign origin quoted exwarehouse, ex-showroom, or off-the-shelf.
- ii. All applicable taxes which will be payable on the goods if the contract is awarded.
- iii. The price for inland transportation, insurance, and other local costs incidental to delivery of the goods to their final destination, if specified in the **BDS**.
- iv. The price of other (incidental or allied) services, if any, listed in the **BDS**.

#### b) For goods offered from abroad:

- i. The price of the goods shall be quoted CIF named port of destination, or CIP border point, or CIP named place of destination, in the Procuring Agency's country, as specified in the BDS. In quoting the price, the Bidder shall be free to use transportation through carriers registered in any eligible countries. Similarly, the Bidder may obtain insurance services from any eligible source country. Or
- ii. The price of the goods quoted FOB port of shipment (or FCA, as the case may be), if specified in the **BDS**. or
- iii. The price of goods quoted CFR port of destination (or CPT as the case may be), if specified in the **BDS**.
- iv. the price for inland transportation, insurance, and other local costs incidental to delivery of the goods from the port of entry to their final destination, if specified in the **BDS**.
- v. The price of (incidental) services, if any, listed in the BDS.
- 15.7 Prices proposed on the Price Schedule for goods and related services shall be disaggregated, where appropriate as indicated in this Clause. This desegregation shall be solely for the purpose of facilitating the comparison of Bids by the Procuring Agency. This, shall not in any way limit the Procuring Agency's right to contract on any of the terms and conditions offered: -

#### a) For Goods: -

- i) the price of the Goods, quoted as per applicable INCOTERMS as specified in the **BDS**



  - h) "Defective Goods" are those goods which are below standards, requirements or specifications stated by the Contract.
  - i) "Delivery" means the transfer of the goods from the supplier equipment, machinery, and /or other materials which the Supplier is required to supply to the Procuring Agency under Contract.
  - j) "Effective Contract date" is the date shown in the Certificate of Contract Commencement issued by the Procuring Agency upon fulfillment of the conditions precedent stipulated in GCC Clause 3.



#### **Preamble**

- The Bill of Quantities shall be read in conjunction with the Conditions of Contract, Specifications and Drawings. 1.
- 2. The quantities given in the Bill of Quantities are estimated and provisional, and are given to provide a common basis for bidding. The basis of payment will be the actual quantities of work executed and measured by the Contractor and verified by the Engineer and valued at the rates and prices entered in the priced Bill of Quantities, where applicable, and otherwise at such rates and prices as the Engineer may fix as per the Contract.
- 3. The rates and prices entered in the priced Bill of Quantities shall, except insofar as it is otherwise provided under the Contract include all costs of Contractor's labour, supervision, materials, execution, insurance, profit, taxes and duties, together with all general risks, liabilities and obligations set out or implied in the Contract. Furthermore, all duties, taxes and other levies payable by the Contractor under the Contract, or for any other cause, as on the date 28 days prior to deadline for submission of Bids, shall be included in the rates and prices and the total Bid Price submitted by the Bidder.
- 4. Prices quoted by the Supplier will remain fixed during the contact period. Except otherwise mentioned in the Contract, the Supplier shall NOT be entitled for price adjustment on account of any change in wages, material prices, POL prices, tax rates etc. whatsoever on any other account.
- 5. The Supplier hereby irrevocably and unconditionally waives all claims, direct, indirect or consequential arising out of price escalations, decrease or increase in quantities etc. in connection with the Agreement.
- A rate or price shall be entered against each item in the priced Bill of Quantities, whether quantities are stated or 6. not. The cost of items against which the Contractor will have failed to enter a rate or price shall be deemed to be covered by other rates and prices entered in the Bill of Quantities.
- 7. The whole cost of complying with the provisions of the Contract shall be included in the items provided in the priced Bill of Quantities, and where no items are provided, the cost shall be deemed to be distributed among the rates and prices entered for the related items of the Works.
- Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by 8. the quantity, the unit rate as quoted will govern, and the line total will be corrected accordingly.
- 9. Each cutting should be signed by the authorized person.
- 10. The brand names have been provided in order to establish a standard of performance and reliability. However, it does not indicate a preference for a particular brand. The bidder may propose other brands which can be accepted subject to necessary tests to establish equivalency.
