- a) SBP- Banking Services Corporation invites electronic bids (e-Bids) from bidders who are registered with PPRA for e-procurement on "e-Pak Acquisition and Disposal System (EPADS)", having Income & Sales Tax registration and are on Active Taxpayers List (ATL) of FBR.
- b) The e-bidding documents for *Supply, Installation & Technical Support of Cyber Threat Intelligence Solution* as per regulations, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on EPADS at (<a href="www.eprocure.gov.pk">www.eprocure.gov.pk</a>).
- c) Procurement method shall be 'Single Stage Two Envelope Procedure' in line with Rule 36 (b) of the Public Procurement Rules 2004. All e-Bids must be accompanied by Bid Security amounting to **Rs.300,000/**in an acceptable form in favor of SBP Banking Services Corporation. ## A. INTRODUCTION
