Similarly, this process will be followed for remaining two rounds. The scope of all rounds/review exercise is same as mentioned in TORs of the RFP document. ### **Introduction**

SBP (BSC) Sialkot office has recently been shifted to a new purpose built building, and it has been decided to dispose off the old office building situated at Kutchery Road Sialkot (Property) at fair market value. To determine a fair market value, SBP has decided to engage services of four valuers listed on the Pakistan Bankers Association (PBA). The Reserve Price of the Property will be determined based on the average of Property value assessed by three (03) valuers. In case of an outlier value among the valuation of the three valuers, the same would be resolved through review exercise based on the fourth valuation. The process of engaging firms for three rounds and one review exercise (if required), seeks to ensure that setting of reserve price for the property is accomplished in a fair and transparent manner.

### **Objectives**

The State Bank of Pakistan seeks to engage the services of four Valuation Firms (separately for each round of valuation and review exercise) enlisted in unlimited category of PBA panel of valuers to determine the current market value of the Property mentioned below:
