# A. INTRODUCTION

1. Scope of Bid	1.1	The Procuring Agency (PA), as indicated in the Bid Data Sheet (BDS) invites Bids for the Supply, Installation, Integration, Maintenance & Technical Support of Smart Meeting Room Telepresence Solution as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to supply and install the information systems within the specified period and timeline(s) as stated in the BDS.
	1.2	Unless otherwise stated throughout this document definitions and interpretations shall be as prescribed in the General Conditions of the Contract (GCC).
<ul><li>2. Source of Funds</li><li>3. Eligible Bidders</li></ul>	2.1 3.1	Source of funds is referred in Clause-2 of Invitation for Bids.  A Bidder may be natural person, company or firm or public or semipublic agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.
	3.2	The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.
	3.3	Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.
	3.4	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.
	3.5	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.
	3.6 .	Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before

	participating in the national/international competitive tendering with
	the exception of such procurements made by the foreign missions of
	Pakistan. For such purpose the bidder must have to initiate the
	registration process before the bid submission and the necessary
	evidence shall be submitted to the procuring agency along with their

3.7	A Bidder shall not have a conflict of interest. All Bidders found to

3.8	A Bidder may be ineligible if –

	3.9	Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.
	3.10	Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.
	3.11	Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged.
4. Eligible Information Systems	4.1	<ul> <li>For the purposes of these Bidding Documents, the Information System means all: <ul> <li>a) the required information technologies, including all information processing and communications-related hardware, software, supplies, and consumable items that the Supplier is required to supply and install under the Contract, plus all associated documentation, and all other materials and goods to be supplied, installed, integrated, and made operational (collectively called "the Goods" in some clauses of the ITB); and</li> <li>b) the related software development, transportation, insurance, installation, customization, integration, commissioning, training, technical support, maintenance, repair, and other services necessary for proper operation of the Information System to be provided by the selected Bidder and as specified in the Contract.</li> </ul> </li> </ul>
	4.2	All Information System made up of goods and services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to the supply and installation information systems. For purpose of this Bid, ineligible countries are stated in the section-4 titled as "Eligible Countries".
	4.3	For purposes of this Clause, "origin" means the place where the goods and services making Information System are produced in or supplied from. An Information System is deemed to be produced in a certain country when, in the territory of that country, through software development, manufacturing, or substantial or major assembly or integration of components, a commercially recognized product result that is substantially different in basic characteristic or in purpose or utility from its component.  The nationality of the supplier that supplies and install the
		Information System shall not determine the origin of the goods.

	4.5	To establish the eligibility of the Goods and Services making Information System, Bidders shall fill the country-of-origin declarations included in the Form of Bid.
	4.6	If so required in the <b>BDS</b> , the Bidder shall demonstrate that it has been duly authorized for the supply and installation of Information System in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the Information System indicated in its Bid.
5. One Bid per Bidder	5.1	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	5.2	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.
	5.3	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
6. Cost of Bidding	6.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

7. Contents of Bidding Documents	7.1	The Contents of the Bidding Documents listed below should be read in conjunction with any addenda issued in accordance with ITB 9.2 include:  Section I -Invitation to Bids  Section II Instructions to Bidders (ITBs)  Section III Bid Data Sheet (BDS)  Section IV Eligible Countries  Section V Technical Specifications, Schedule of Requirements  Section VI Forms – Bid  Section VII General Conditions of Contract (GCC)  Section VIII Special Conditions of Contract (SCC)  Section IX Contract Forms
	7.2	The number of copies to be completed and returned with the Bid is specified in the <b>BDS</b> .
	7.3	The Procuring Agency is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Procuring Agency or the signed pdf version from downloaded from the website of the Procuring Agency. However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.
	7.4	The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder's risk and may result in the rejection of his Bid.
8. Clarification of Bidding Documents, Pre- Bid Meeting and Site Visit	8.1	A prospective Bidder requiring any clarification of the Bidding Documents may notify the Procuring Agency in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the <b>BDS</b> .
	8.2	The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in <b>ITB 23.1.</b> However, this clause shall not apply in case of alternate methods of Procurement.
	8.3	Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source.  In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.

	8.4	Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under <b>ITB 9.</b>
	8.5	If indicated <b>in the BDS</b> , the Bidder's designated representative is invited at the Bidder's cost to attend a pre-Bid meeting at the place, date and time mentioned <b>in the BDS</b> . During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.
	8.6	Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-Bid meeting shall be made by the Procuring Agency exclusively through the use of an Addendum pursuant to <b>ITB 9.</b> Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.
	8.7	The Bidder may wish to visit and examine the site or sites of the Information System and obtain for itself, at its own responsibility and risk, all information that may be necessary for preparing the bid and entering into the Contract. The costs of visiting the site or sites shall be at the Bidder's own expense.
	8.8	The Procuring Agency will arrange for the Bidder and any of its personnel or agents to gain access to the relevant site or sites, provided that the Bidder gives the Procuring Agency adequate notice of a proposed visit of at least seven (07) days. Alternatively, the Procuring Agency may organize a site visit or visits concurrently with the pre-bid meeting, as specified in the BDS for ITB Clause 8.5. Failure of a Bidder to make a site visit will not be a cause for its disqualification
	8.9	No site visits shall be arranged or scheduled after the deadline for the submission of the Bids and prior to the award of Contract.
Bidding Documents	9.1	Before the deadline for submission of Bids, the Procuring Agency for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder or pre-bid meeting may modify the Bidding Documents by issuing addenda.
	9.2	Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to <b>ITB 7.1</b> and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the Procuring Agency. The Procuring Agency shall promptly publish the Addendum at the Procuring Agency's web page identified in the BDS:

	Provided that the bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.
9.3	To give prospective Bidders reasonable time in which to take an addendum/corrigendum into account in preparing their Bids, the Procuring Agency may, at its discretion, extend the deadline for the submission of Bids:  Provided that the Procuring Agency shall extend the deadline for submission of Bid, if such an addendum is issued within last three (03) days of the Bid submission deadline.

10. Language of Bid	10.1	The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Procuring Agency shall be written in the English language unless otherwise specified in the BDS. Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the BDS, in which case, for purposes of interpretation of the Bidder, the translation shall govern.
11. Documents Constituting the Bid	11.1	The Bid prepared by the Bidder shall constitute the following components: -
		a) Form of Bid and Bid Prices completed in accordance with ITB 14 and 15;
		b) Details of the Sample(s) where applicable and requested in the <b>BDS</b> .
		c) Documentary evidence established in accordance with ITB 13 that the Bidder is eligible and/or qualified for the subject bidding process;
		d) Documentary evidence established in accordance with <b>ITB 13.3(a)</b> that the Bidder has been authorized by the manufacturer to deliver the goods and services making Information System into Pakistan, where required and where the supplier is not the manufacturer of those goods and service making Information System;
		e) Documentary evidence established in accordance with ITB 12 that the goods and services making Information System to be supplied by the Bidder are eligible, and conform to the Bidding Documents;
		f) Bid security or Bid Securing Declaration furnished in accordance with <b>ITB 18</b> ;
		g) Duly Notarized Power of Attorney authorizing the signatory of the Bidder to submit the bid; and
		h) Any other document required in the <b>BDS</b>

Documents Establishing Eligibility of the Information System	12.1	Pursuant to <b>ITB 11</b> , the Bidder shall furnish, as part of its Bid, all those documents establishing the eligibility in conformity to the terms and conditions specified in the Bidding Documents for all goods and services making information system which the Bidder proposes to deliver.

and Conformity to Bidding Documents	12.2	The documentary evidence of the eligibility of the Information System shall consist of a statement in the Price Schedule of the country of origin of the goods and services making Information System offered which shall be confirmed by a certificate of origin issued at the time of shipment.

System Integrator must install multiple Video Conferencing Codec with Quad Cameras, microphones to ensure the high availability and enhance video session experience. Further, Supplier can integrate telepresence system with existing redundant Video Conferencing Management Servers or can provide new redundant Video Conferencing Management solution including meeting server and recording solution that will integrate existing Cisco Video Endpoints. All cameras should be installed to capture picture of all participants, Microphones to ensure lowest audible pick up from any point of the room and speakers to distribute sound evenly to all the participants.

### 2.2 Operation and Maintenance phase

Operational Acceptance means that the offered solution has been installed, configured, integrated and operational as per contract. At least One (01) month of successful operations of the installed equipment & supplies, in accordance with the purchaser requirement will confirm the Operational Acceptance and the purchaser will sign/issued the Operational Acceptance Certificate. SLA will start from the date of the issuance of Operational Acceptance Certificate.

The Supplier must provide OEM backed Maintenance and Technical Support (Wherever applicable) of entire solution for the period of five (5) years. The bidder shall carefully go through BOQs, Specifications, site conditions to determine complete requirement and to propose complete integrated solution. The Supplier must include 4 hours OEM hardware replacement support for telepresence system within SBP premises. If an OEM is not having local depot in Karachi then backup should be maintained in SBP premises.

#### 2.3 Product Brochures/Data

The Supplier will provide Product Data for each element of solution. Product data shall include printed information such as manufacturer's installation instructions, catalogue, standard color charts, templates, standard diagrams, operation and maintenance manuals. The Supplier must supply products that meet the performance requirements outlined in the Contract Documents and those recommended in writing by the manufacturer for the intended purpose. The materials and equipment to be utilized in the project must be of the highest quality, representing the latest models of standard products from reputable manufacturers, and must not exhibit any signs of defects or impurities.

All proposed equipment must be current-generation, fully supported by the manufacturer, and should not be end of support for the period of at least 7 Years. Equipment must be covered under OEM Support and ongoing technical support for entire contract period. The Supplier must transport and manage products following the manufacturer's guidelines all the way to the installation site. The Supplier will ensure that necessary equipment and personnel is available to handle the products, utilizing methods that prevent any contamination, defacement, or harm.

### 2.4 Safety and Security Procedures

The Supplier must follow all applicable laws and regulations for workforce safety and security. All access to the SBP premises will be allowed after verification of Law Enforcement Agencies. All Workforce must be well dressed and equipped with necessary safety tools to prevent any injury or loss of life. The Purchaser have to right to halt the work during the day and may request Supplier to work during the night as well on holidays.

### 3 **Project Completion**

The project must be completed within 7 Months from Notification of award of Contract. The bidder will provide detailed project implementation plan (PIP) which should not exceed 07 months. The delivery will be considered complete when offered supplies and equipment as per contract, will be delivered at purchaser's sites. The Installation will be considered complete when offered supplies and equipment will be installed as per contract at purchaser's sites. The Integration will be considered complete when all the necessary configuration of the offered supplies and equipment is performed as per contract and ready for operations. The Purchaser will provide written confirmation for delivery, Installation and Integration.

### 4 Project Management

The supplier will assign a senior representative (s) who will oversee the implementation of the project along with purchaser project team. The supplier will provide the project plan including resource requirements, communication plan and risk plan. The supplier will be required to engage OEM resources whenever required during the contract period for resolution of the issues without any additional cost to the purchaser.

### 5 Onsite Training

The supplier will provide comprehensive hands on technical training for installation, administration, configuration, security, troubleshooting, maintenance, preventive maintenance and performance tuning to ten (10) SBP officers.

#### 6 **Documentation**

The supplier will provide artifacts, documents; manuals, catalogs and all other necessary documents required from the administration of the solution. All these documents shall become the property of purchaser. The supplier shall provide atleast below mentioned documents;

- i. Introduction along with 3D design and layout diagram of the complete solution
- ii. Procedure for installation and configuration of the equipment
- iii. Technical details of equipment
- iv. Operation, maintenance and troubleshooting documents

### 7 Technical Submittals Review and Approval

The supplier will submit the detailed technical submittals to purchaser for review and approval before placing the order to OEM. The following details should be provided in technical submittals including any other detail subsequently required by the purchaser.

- 7.2 Drawings and implementation plans document/video as per site conditions.
- 7.3 Data Sheets.
- 7.4 BOQ of all items with make, model and SKU of items being ordered.
- 7.5 Vendor's declaration that offered solution meet Tender Specifications.

Note: Failure of the Contractor to process submittals for review or find alternatives in case of rejections shall not relieve the contractor of his responsibilities under the Contract. Further, The Contractor shall not be relieved of responsibility for deviations from the Contract, or

errors of any kind in the submittals, or from the necessity of furnishing work required by the Contract, which may have been omitted from the submittals marked with the appropriate Action. The review of individual items in submittals shall not be construed as a review of the complete assembly in which it functions.

No authorization of an increase in Contract Price or time shall be implied by comments marked on submittal transmittals by the Engineer. The Contractor shall be responsible for costs for alterations to the Works caused by discrepancies, errors or omissions in submissions, irrespective of whether the submissions have been reviewed or not.

		8.4	The Supplier shall acquire in its name all permits, approvals, and/or licenses from all local, state, or national government authorities or public service undertakings in the Procuring agency's Country that are necessary for the performance of the Contract, including, without limitation, visas for the Supplier's and Subcontractor's personnel and entry permits for all imported Supplier's Equipment. The Supplier shall acquire all other permits, approvals, and/or licenses that are not the responsibility of the Procuring agency and that are necessary for the performance of the Contract.

		8.8	The Supplier shall permit the Procuring Agency and/or persons appointed by the Procuring Agency to inspect the Supplier's offices and/or the accounts and records of the Supplier and its sub-contractors relating to the performance of the Contract, and to have such accounts and records audited by auditors.
