**INVITATION TO e-BID
(Supply, Installation, Testing and Commissioning of Fire Fighting Equipment at SBP Banking Services Corporation Quetta)**

1. SBP Banking Services Corporation (SBP BSC), invites electronic bids from the suppliers/ contractors/ service providers, who are registered with PPRA for E-Procurement on “e-Pak Acquisition and Disposal system (EPADS)”, having Income & relevant Sales Tax registration and are on Active Taxpayers List (ATL) of FBR.
2. The SBP BSC has reserved the funds for the procurement of fire fighting equipment planned during the financial year 2025-26. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contract for the procurement.
3. For using the EPADS, unregistered bidders may first register on website <https://eprocure.gov.pk> in case of any technical difficulty in registration or using EPADS, the prospective bidders may contact PPRA’s technical team.
4. The bidding shall be conducted in line with the Rule 36 (b) - Single Stage Two Envelope Procedure of the Public Procurement Rules, 2004 and any regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Public Procurement Regulatory Authority (from time to time) and is open to all potential bidders.
5. The e-bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on EPADS at [_ \(https://portal.eprocure.gov.pk\)](https://portal.eprocure.gov.pk).
6. All electronic Bids must be accompanied by a Bid Security i.e., **Rs. 100,000/-** in the form of Demand Draft/Pay Order/CDR/Bank Guarantee in favor of SBP BSC. The prospective bidders shall upload scanned copy of Bid Security on EPADS.
7. Original bid security must be submitted to the procuring agency on or before the closing time of bid submission on the below mentioned address, failing which the bid shall be rejected.
8. The electronic bids, must be submitted by using EPADS on or before 11-Mar-2026 at 11:00 AM. Manual bids, shall not be accepted. Electronic Bids will be opened by using EPADS publicly on the same day on 11-Mar-26 at 11:30 AM at Office of Deputy Chief Manager, SBP BSC Quetta. In case the bid opening date falls on a public holiday, the bids will be opened on the next working day at the same time and on the same venue.
