The bidders shall be liable to arrange all necessary coverage for his/her employees as per applicable law, including Group, Life, Disability and Health insurance from a reputable Insurance Company along with coverage from EOBI and PESSI or equivalent authority.	✓
The bidders should not have history of any termination on account of service related issues.	✓
The bidders must be compliant to all prevailing laws /statutes of the Country including Labor Laws, Wage Board, Industrial Relations Act, 2013 etc.	✓


